Ruto declares pension and gratuity tax-exempt

resident William Ruto has announced that pensions and gratuity payments for workers both in the private and public sectors will be tax-free beginning the next financial year.

This reform measure, the President explained, is proposed in the Finance Bill 2025 in recognition of the service and sacrifice of workers in their active years, and a step towards ensuring that they retire in dignity.

Speaking at Uhuru Gardens Stadium, Nairobi, during this year's Labour Day celebrations on Thursday, he expressed the government's commitment to workers' welfare.

To improve workers' takehome pay, President Ruto said employers will now be required to apply eligible tax reliefs and exemptions directly when calculating Pay As You Earn (PAYE), a significant shift from the current system where such reliefs have to be claimed from the Kenya Revenue Authority.

In response to Central Organisation of Trade Unions (Cotu) Secretary-General Francis Atwoli's complaint that some employers have not effected a 6 per cent minimum wage increase awarded in 2024, the President directed the Ministry of Labour to ensure that the employees are awarded what they deserve without discrimination.

"It's unacceptable for employers not to implement the minimum wage increase. The Ministry of Labour should ensure the issue is addressed," President Ruto said.

Meanwhile, the President said the government has made significant progress in addressing the long-standing shortage of teachers by hiring 76,000 in the past two years and an additional 20,000 tutors set to be hired in January 2026.

He pointed out that his administration has significantly reduced the teacher shortage that stood at 116,000 in 2022.

"We have set aside KSh2.4 billion to hire an additional 20,000 intern teachers



starting January 2026," the President announced

He also pointed out that the government has allocated KSh1.6 billion for the capacity building of teachers and another KSh1 billion for promotion.

"These investments have improved student-teacher ratio, enhanced literacy and numeracy outcomes, and created stable employment in communities across the country," he said.

Furthermore, President Ruto assured Kenyans of his commitment to taking the country to the next level in terms of development.

He said it was time leaders focused on service delivery, noting that elections are two years away.

"We can't make progress as a country if we don't make the right decisions. I want to promise the people of Kenya that I will always make the right decisions to change the destiny of this country," he said.

Prime Cabinet Secretary Musalia Mudavadi praised President Ruto's efforts in transforming the country, saying Kenya is the largest economy in East and Central Africa.

"We should all know that the biggest threat to a nation is not terrorism, but the collapse of institutions. Our institutions have been solid because of the good leadership of President Ruto," he said.

Labour Cabinet Secretary Alfred Mutua called for an end to sexual harassment at the workplace, urging managers to foster safe and respectful environments for all employees.

Mr Mutua said his office has received numerous complaints about harassment, warning that the unethical trend must stop. The CS stressed the need to discourage inappropriate conduct and explicitly urged managers to stop engaging in sexual relationships with junior staff.

COTU Secretary-General Francis Atwoli urged Kenyans to embrace peace and unity and refuse to entertain any efforts to bring discord among Kenyans.

He said residents in some parts of Africa, including Goma in the Democratic Republic of Congo, are undergoing untold suffering due to instability.

"As Kenyans, we must guard the peace we are enjoying for the sake of prosperity," he said.

The COTU boss urged employers to implement President Ruto's directive on the 6 per cent wage increase in last year's Labour Day celebrations.

President Ruto inspects Talanta Sports City progress

Ruto has expressed satisfaction with the progress in construction world-class Nairobi's Talanta Sports City that will significantly elevate country's sports profile.

The President said 3,300 workers have been hired at the stadium, with 2,000 working during the day, while 1,300 are engaged at night in the 60.000-seater facility.

"With this pace, the Talanta Sports City, with a football pitch while outside the stadium is an athletic field and rugby training grounds, will be ready by December 2025," he said when he visited the facility on Friday.

President Ruto pointed out that investment in physical infrastructure, including affordable housing, modern markets and special economic zones, has so far employed

"This is how we are going to build our nation by harnessing knowledge, skills and the expertise of our youth," said President Ruto.

He said the sports facility will be complete before the end of the year in readiness for hosting the Africa Cup of Nations (Afcon) in 2027.

"I am happy with the progress being made here. I am optimistic we'll beat the December date." President Ruto said.

He said the government was committed to improving sporting facilities to offer quality training grounds for the country's sportsmen and

He spoke at State House Nairobi, on Friday, during the reception of the UEFA Champions League Trophy.

Sports Cabinet Secretary Salim Mvurya, Footbal Kenya Federation President Hussein Mohammed and former United Manchester star Bastian Schweinsteiger were also present.

President Ruto said the



government, in collaboration with other stakeholders, will continue to invest sufficient resources in nurturing football talent and revamping football infrastructure.

"I urge the Football Kenya Federation and all stakeholders to take lead in revitalising the game by nurturing talent from the grassroots to the national and international levels," he said.

The President explained that Kenva has an abundance of football talent, which requires focus on identifying. nurturing, and developing it through training, support and the necessary infrastructure.

"We also have much to learn from global football

powerhouses like Germany where Bastian comes from - about what it takes consistently remain competitive on the world stage," he said.

At the same time, the President emphasised need to make football and other sports a source of income and wealth, especially for young people.

"That is why the government came up with Talanta Hela, an initiative for monetising talents. Many of our youth have already benefitted," President Ruto pointed out.

He said he was pleased to note that Kenya is one of only five African countries selected to host the UEFA trophy during this year's tour.

"On behalf of the people of Kenya, let me say we are truly honoured to host the trophy once again given the tremendous and passionate support that football enjoys in our country," he said.

He thanked UEFA and Kenva Wine Agency Ltd for bringing the trophy to Kenya, saying it is a delight for football fans.

"Many of them may never have the opportunity to be in a stadium and experience the action firsthand. Simply seeing the trophy is, therefore, a very special moment for them," he said

NCRRA meeting



March 3rd. 2025, North Coast Residents and Ratepayers Association (NCRRA) Committee, led by Hon. Chairman Ali Taib, held a consultative meeting with the Mombasa County Governor to address critical issues affecting Nyali residents. Key matters discussed included the increment of business permits, with the County Government of Mombasa committing further public participation, acknowledging the need for

revenue to support county

zonina development, CGM noted that Nyali is classified as a high density tower zone under the JICA planning framework, despite the absence of formal zoning regulations. NCRRA is to submit a list of noncompliant developments for action.

Concerns about noise pollution and solid waste management were also tabled. The Governor pledged to issue an Executive Order to address noise violations, and revealed plans for the Kipevu opening next month

A new tender for waste management underway. On March 20th, NCRRA Committee met the CECM for Lands and Urban Planning at Bima Towers. Discussions focused on building approval criteria, zoning clarity, and inclusion of NCRRA decision making bodies. The CGM acknowledged gaps in the objection process and committed to implementing an online system.

A proposal for establishing green zones in Nyali and fully implementing the ISUDP Plan 2035 was also raised. Lastly, on April 23rd, the Committee paid a courtesy visit to MOWASSCO Nyali Unit Manager Ms. Naima Yusuf. They addressed issues such as erratic water supply, uncompleted repairs, and leakages. Ms. Naima highlighted staff shortages, lack of equipment, and client interference as major hurdles.

Residents were encouraged to apply for connection to the new water system. NCRRA remains committed to advocating for sustainable growth and improved services for all Nvali residents.

Kenyan, global scientists begin marine research expedition

cientists from the Kenya Marine and Fisheries Research Institute (KMFRI), in collaboration with experts from across Africa and Europe, have launched a major scientific expedition aboard the R/V Dr. Fridtjof Nansen, a world-renowned Norwegian research vessel. The research cruise, which begins today-April 24, 2025—in Mombasa. will span approximately ten days, covering Kenva's coastal and marine waters, including the Exclusive Economic Zone (EEZ).

The primary mission of this expedition is to assess fish biomass, examine oceanographic and evaluate overall health—critical ecosystem elements for the sustainable management of resources and Scientists will collect new data on the Kenyan segment of the Indian Ocean by analysing key oceanographic parameters such as sea surface temperature, salinity, depth profiles, and biological including productivity, phytoplankton, zooplankton, fish larvae diversity distribution, and biomass.




Fig. 1: showing marine zones, depth contours, planned survey locations, major coastal towns and key to research activities. (Source: Sailing Order R/V Fridtjof Nansen Leg 1.4, modified by

The data will contribute to regional resource assessments led by the Southwest Indian Ocean Fisheries Commission (SWIOFC). Survey, locations, transects, bathymetry and planned activities are outlined in the accompanying map (Figure 1).

This expedition also presents a valuable opportunity for capacity building and international collaboration. A significant number of the researchers on board are early-

career oceanographers from universities and institutions in Europe and Africa. KMFRI team is listed in Table 1

The Kenyans are joined by scientists from Norway, France, Portugal, Spain, Côte d'Ivoire, Ghana, Tanzania, Angola, Mozambique and South Africa.

According to the vessel's sailing orders, the Kenyan leg of the cruise will begin at a location near Vanga in Kwale County of south coast and conclude off Kiunga in Lamu County of the north coast.

Operated under the EAF-Nansen Programme—a collaboration between the Food and Agriculture (FAO) the Norwegian Agency for Development Cooperation (NORAD)—the R/V Dr. Fridtjof Nansen seen partly in Fig. 2 is equipped with state-of-the-art instruments for conducting marine ecosystem research and supporting development partner countries. Kenya stands to benefit greatly through enhanced collaboration with Norway and the broader scientific community.

A Legacy of Research in Kenya

The R/V Dr. Fridtjof Nansen has a long history of contributing to marine science in Kenya. Between 1980 and 1983, it conducted four major surveys along the Kenya coast, focusing on hydrography and the diversity and biomass of pelagic and demersal fish. Key missions are summarized in Table 2.

These surveys provided extensive data on Kenya's continental shelf and slope, revealing a rich biodiversity, particularly among small pelagic fish species. Their findings have been crucial in guiding fisheries management and marine policy.

Significance of the Current Research Cruise

This latest expedition is part of a broader effort to better understand marine ecosystems in the Western Indian Ocean. It follows recent cruises in Tanzania (Leg 3) and Mozambique (Legs 1 & 2). The insights gained will inform national and regional marine policies, support conservation initiatives, and drive sustainable Blue Economy development in Kenya.



Pangaea is the name given to the supercontinent that made up the Earth's surface during the Permian to Triassic periods. This single landmass was also surrounded by a single ocean, known as Panthalassa. The breakup of Pangaea, which eventually led to the current configuration of the continents. began around 230 million years ago.

The first to systematize the hypothesis of this supercontinent's existence was Alfred Wegener, through his theory of continental drift in the early 20th century. The explanation for the mechanism behind the movement of the continental masses emerged only in the 1960s and is known as the theory of plate tectonics.







