MOMBASA TO AFRICA VIA DONGO KUNDU



resident William Ruto has cancelled Dongo Kundu Special Economic Zone (SEZ) compensation and ordered for re-evaluation of the beneficiaries.

He said a comprehensive audit of the Dongo Kundu land compensation must be carried out to get the genuine people. "I have directed the PS Interior Raymond Omollo to make sure that the list is vetted to ensure genuine people are compensated," said President Ruto.

President Ruto, at the same time, said the Government will set up a Level Six Hospital in coast to the level of Kenyatta National Hospital (KNH).

He said the move will be part of efforts to transform the health sector and ensure efficiency in service delivery at the county.

Speaking at the Mama Ngina Waterfront, during an interdenominational service, Dr Ruto assured that the Mombasa port will not be privatised.

He said the Port will instead be consissioned for a limited period to unlock its potential.

The Head of State noted that the Government has set aside Sh 1 billion to buy land from absentee landlords to settle squatters.

"As promised, Kenya Kwanza has the answer to the perennial land question in Coast. We will do as we promised," said President Ruto.

President Ruto said no part of the country will be left behind in terms of development because of political affiliations.

He said the Government will serve all Kenyans irrespective of how they voted during the last General Election.

He noted that Kenyans buried politics based on tribalism last year and instead elected leaders based on their manifesto.

"We had a peaceful election last year where Kenyans voted for leaders because of their agenda and not on tribal affiliations," said President Ruto

Senate Speaker Amason Kingi urged Kenyans to be patient, saying President Ruto has the heart and the will to transform the country.

"The initiatives being carried out by this administration will take this country far in terms of development," said Mr Kingi.

Earlier President, President Ruto asked Coast leaders to



unite and work together for the sake of development.

He advised the leaders to have a broader view of development and focus on projects that are beneficial to the residents.

Dr Ruto assured them that he was ready to work with all elected leaders, saying they had only one agenda of serving the people.

Speaking at State House, Mombasa when he hosted leaders from Coast region, President Ruto said the Government was keen to implement projects that can create wealth and employment for the people.

He singled out investments in affordable housing, healthcare, food security and the blue economy as some of the projects that have direct impact on the lives of the citizens.

"It's for us as leaders to figure out how we are going to work together for the benefit of our people," said President

He thanked MPs for passing the necessary legislations to help in the implementation of universal healthcare that had stalled for the last 15 years.

The Head of State argued that he took difficult decisions to implement the initiatives on affordable housing, saying Kenyans would appreciate his move in two years time.

"The whole idea about the housing project is to create employment opportunities, access to decent homes and eliminate slums in our country," said President Ruto.

On food security, the President assured the leaders that proper mechanisms have been put in place to construct mega dams across the country to increase land under irrigation to produce enough food for consumption and surplus for sale.

He noted that water harvesting strategy on dams will soon be taken to Parliament for approval as part of efforts to ensure the country's food security.

The meeting was attended by Governors and MPs from the Coastal counties of Mombasa, Kwale, Taita Taveta, Kilifi, Lamu and Tana River.

Irrigated agriculture remains key to reduction of poverty



resident William Ruto has said irrigated agriculture remains key to reduction of poverty and attainment of food security in the country.

He said interventions aimed at increasing water availability for livelihood and domestic activities have great potential to transform the lives of rural communities through

President Ruto said his administration will continue to improve access to water irrigation through construction of dams and water pans across the country.

processing and value addition is meant to reduce postlosses, eliminate brokers and encourage youth to pursue farming by availing a ready market and guaranteed returns," said President Ruto.

The President made the remarks during the opening of the Bura Irrigation and settlement scheme rehabilitation and project headworks gate and inspection of gravity canal works, in Tana River County.

The Head of State noted that the rehabilitation of Bura Irrigation Scheme will increase the land under cultivation from 12,000 to 25,000 acres.

He argued that the implementation of the project will ensure reliable water supply, which will improve agricultural productivity.

While President commissioned the Integrated Fruit Processing Plant, which will boost the earnings of fruit farmers in the region. The facility has created 200 employment opportunities and has trained over 1,000 farmers on good agricultural practices.

He also issued Fisheries Community Grant Cheques to support the fishing community in Tana River County.

The Head of State asked parents in the region to ensure their children get access to education, saying it was the greatest equaliser in the society.

"It is our responsibility to plan for the employment of our youth. That's why we are creating opportunities in the blue economy, housing, digital and value addition chains for their benefit." he

Deputy Rigathi Gachagua said the Government was committed to transform the lives of Kenyans in arod areas through initiation of irrigation projects.

He said President Ruto's administration will empower Kenyans providing conducive environment for investments.

"It's time leaders forget

about issues of the last election and support the Government for the sake of development," said Mr Gachagua

He asked residents of Tana River to take advantage of the Bura Irrigationn project to grow cash crops that will boost their earnings.

Senate Speaker Amason lauded President administration spearheading major development projects marginalised counties.

Kenya and Czech Republic to enhance their bilateral relations

enya and Czech Republic have pledged to enhance their bilateral relations and exploit existing investment opportunities in the two countries.

President Ruto said the two countries will soon sign a negotiated economic agreement that will see Kenya access duty- free and quota -free markets.

He said the two nations will build partnerships that will intensify cooperation in various areas of mutual interest.

Speaking at State House, Nairobi, when he held bilateral talks with Czech Republic Prime Minister Petr Fiala, President Ruto argued that an equal partnership was paramount for mutual benefits.

"Your Excellency, I wish to congratulate you for launching the "Look Africa Policy". Africa is a continent rich in natural resources, ranging from land, water, oil, natural gas and other minerals," said President Ruto.

He said Africa has highly skilled human resources, forests and wildlife, among other resources, in abundance, saying Czech resolve to focus on Africa was timely and highly valued.

President Ruto noted that Czech business delegation, which accompanied the Prime Minister would had constructive engagements with its Kenyan counterparts during the Business Forum

held on Monday

The Head of State observed that there are many potential opportunities for investment in some of the competitive areas of our economy including pharmaceuticals, textile. agro-processing, hospitality and fintech. Others are green energy, ICT, health and manufacturing of industrial parts and machinery.

Dr Ruto said digital economy is transforming the way people work and the skills they need in the everchanging world of work.


He said Kenya aspires to become a key player in the digitisation space as the country is a world leader in mobile money transfer and usage.

President Ruto noted that Czech Republic has key interests in digital governance, prosperity and sustainable development, cyber-security and digital self-determination.

"I, therefore, welcome and look forward to a possible joint partnership in this important sector, especially in enabling e-Government among other initiatives," said Dr Ruto.

On health, President Ruto appreciated Czech Republic's support through the Slovak-Czech sponsored paediatric heart surgery mission at the Mater Hospital, which was launched in March, 2019.

"This programme has, indeed, changed lives of mother and child, enhanced capacity of our health



personnel and, ultimately, contributed to our universal healthcare agenda," said President Ruto.

He also lauded the ongoing cooperation through the Medevac Programme, which provides training to health personnel in hospitals in Kilifi, Vihiga, Malindi and Mbagathi.

Dr Ruto said the sharing of knowledge, experiences opportunities contribute greatly to the improvement of the quality of healthcare and medical services offered in Kenya.

President Ruto invited Czech Republic to endorse and support the Call to Action by world leaders through the "Nairobi Declaration", the key outcome of the recent Africa Climate Summit.

"Among other things, the declaration calls for a reformed and inclusive global climate financing architecture. We

hope that the Czech Republic can support this outcome during COP28 in Dubai later this month," said President Ruto.

Prof Fiala on his part said investors from his country will take advantage of the existing cordial relations to exploit opportunities in Kenya.

"Now that I have come here, we have sorted out many things, which hindered our cooperation. Our relations are now excellent and more Czech companies will invest here," said Mr Fiala.

He praised Kenya for successfully hosting the recent Africa Climate summit held in Nairobi, noting that it would go a long way in exploring ways of combating climate change.

Prof Fiala said countries must work together to help mitigate the devastating impact of climate change.

KRA to embrace professionalism while discharging its duties

has asked Kenya Revenue Authority (KRA) to embrace professionalism discharging its duties.

He said citizens should be treated with respect and decency while collecting taxes instead of harassing them.

Speaking at the Sarova Hotel Mombasa on Friday, during 2023 Taxpayers Day, Dr Ruto said the Government will not entertain harassment of citizens by KRA officials while collecting taxes.

"I take this opportunity to emphasise to KRA that it is possible to be courteous, kind and gentle to taxpavers and at the same time become even more effective and efficient in tax collection," he said.

At the same time. President Ruto, said the Cabinet has Public approved Audit (Amendment) Bill, 2023, which will enhance the Auditorindependence General's and transparency to ensure proper utilization of public resources through audits and also provide power for fraud investigations.



ample this: You have a start-up or a small office and you don't have a budget to different specialized information technology (IT) professionals to take care of your network management, software management, cloud administration and IT maintenance. You might as well be running a large organization realize that running a large IT department is not only denting your bottom line but is also becoming inefficient and ineffective. Given that IT field is wide and diverse, some IT resources will be idling when not needed. For instance, computers don't need maintenance all year round, neither is cloud, network and security administration a daily affair. Managing and keeping internal IT operations running smoothly can be costly, time consuming and complicated. That is where managed services come in handy.

Managed services refer to the practice of outsourcing the responsibility for maintaining and anticipating the need for a range of processes and functions in order to improve operations and reduce expenses. In the context of IT and business, managed outsourcing the management



company's technology infrastructure, applications, and support services to a third-party provider.

Some popular managed services include: Managed IT support this is where an organization outsources day-to-day IT support and help desk services. organization might also elect to outsource cybersecurity tasks such as threat detection incident response, and vulnerability management that is referred as managed security services. Managed cloud services is where an organization outsources the management of cloud infrastructure and services. Finally, there is managed network services where an organization outsources the monitoring and maintenance of a company's network infrastructure.

that comes with engaging a competent managed services (MSP), them being cost saving and budget control. MSPs often operate on a subscription or contract basis, providing predictable and consistent costs. This helps organizations manage their budgets more effectively compared to the variable costs associated with reactive, break-fix IT services. Outsourcing IT tasks can be more cost-effective than hiring and training an in-house team, especially for specialized skills. Also, by outsourcing non-core functions like IT management, organizations can concentrate on their core competencies and strategic goals, improving overall productivity. NTSA road safety status report



he National Transport and Safety Authority (NTSA) has revealed that from January to October 2023, a total of 3,609 individuals lost their lives in road accidents. However, this marks a notable decrease from the same period in the previous year, where the number of fatalities was recorded at 3,936.

According to the Road Safety status report, the monthly breakdown for 2023 is as follows: January (379), February (340), March (389), April (357), May (340), June (439), July (325), August (327), September (338), and October (330).

The total number of accident victims for 2023 is recorded at 1.880, with vulnerable road users (including pedestrians, motorcyclists, passengers, and pedal cyclists) contributing to 78.8% of all deaths

NTSA attributes the increase in pillion passenger deaths to factors such as speeding vehicles and motorcycles, cycling practices, unsafe hazardous lane changes, distracted riding, the use of mobile phones by drivers and motorcyclists, as well as the failure to wear reflective jackets and helmets.

NTSA cautions drivers on the risks associated with unsafe driving practices and emphasizes the importance of adopting responsible driving

Another activist from Poland said: "I've protested against Greenpeace in horror, as they campaigned to stop Germany's nuclear reactors, leading to much more demand for coal. Now they want to stop Poland transitioning from coal to nuclear. Enough is enough!"

The well-respected Intergovernmental Panel Climate Change (IPCC) agrees, advising nuclear is now a really important tool (its analysis based on irrefutable scientific evidence).


Greenpeace highlights the fact that nuclear plants take long to build and are extraordinarily expensive; also that nuclear remains dangerous for thousands of years. It concludes we don't need nuclear when solar and wind technologies are a cheaper and quicker way forward.

It's a complex argument, but I favour the Aanstoot approach, simply because the climate crisis is the worst extended event to hit our global habitat since homo sapiens first roamed the Rift Valley. We need to pull out all available stops to offset our rush towards a 22nd Century Armaggedon!

Nuclear energy is derived









from uranium, an exhaustible mineral. so not strictly renewable. But the process of nuclear power generation does not produce carbon emissions: and claims a significant effect on reducing emissions over the past five decades. Today, 400 nuclear plants spread over 32 countries, generate 10% of global demand. Lifting this to 15 or 20% takes some of the hardlifting away from renewables such as solar and wind, leading to earlier elimination of fossil fuels, and a speedier result in tackling global heating.

There are significant risks with nuclear, but we need to have confidence that forthcoming plant disasters can be contained, and science can progress to solving the waste storage issue. In contrast, the climate crisis is definitely not being contained. Every day new headlines: forest infernos, devastating floods, intense hurricanes. and droughts killing millions; with links to catastrophic consequences, such as species extinction, water and food shortages; refugee flight, terrorism, and horrendous wars

Going nuclear will help forestall what the scientific world views as impending planetary disaster!

Diabetes Meliitus – a rising non-communicable disease

he term "diabetes" goes back over 3,000 years to its description by Egyptians. Coined by Araetus of Cappodocia (81-133AD), "diabetes" was complemented with "Melitus" by Thomas Willis in 1675, who noted the sweetness of patients' urine and blood. Dobson's confirmation in 1776, of excess sugar in bodily fluids, solidified this understanding.

An important milestone in 1857 was when Claude Bernard highlighted the liver's role in glycogenesis, establishing excess glucose production as the root cause of diabetes. Diabetes remains a critical concern, highlighted annually on November 14th by the International Diabetes Federation for Diabetes Awareness Dav.

What is Diabetes?

This is a condition where blood sugar (glucose) levels become too high. It occurs when the pancreas doesn't produce enough insulin or when the body doesn't respond well to insulin. It affects people of all ages and most forms of diabetes are typically chronic but manageable with medications or lifestyle changes.

Glucose, obtained mainly from carbohydrates in food and drinks, serves as the primary energy source for the body. Insulin, produced by the pancreas, helps glucose enter cells to provide energy. When insufficient insulin is produced improperly glucose accumulates in the bloodstream, leading to high sugar levels (hyperglycemia). If left unmanaged, this elevation in blood glucose can result in various health issues like heart and kidney diseases, eye complications, and nerve

Types of Diabetes

1. Type 2 diabetes is the most common, where the body doesn't produce enough insulin or the cells don't respond properly. It affects adults but can also occur in children.

- 2. Pre-diabetes is a precursor to type 2 diabetes, where blood glucose levels are higher than normal but not yet at the type 2 diabetes level.
- 3. Type 1 diabetes involves the immune system attacking insulin-producing cells in the pancreas for unknown reasons. It's typically diagnosed in children and young adults but can develop at any age and affects up to 10% of the population.
- 4. Gestational diabetes arises during pregnancy and often resolves after childbirth. However, it poses a risk for developing type 2 diabetes later.
- 5. Type 3C diabetes results from pancreatic damage, other than autoimmune damage, impacting insulin production

due to various factors or pancreatic issues, such as pancreas removal.

- 6. Latent autoimmune diabetes in adults (LADA) develops slowly due to an autoimmune reaction, often in individuals over 30.
- 7. Maturity-onset diabetes of the young (MODY), also known as monogenic diabetes, stems from inherited genetic mutations affecting insulin production and usage. Currently, there are over 10 different types of MODY and constitute around 5% of diabetes cases.
- 8. Neonatal diabetes is rare and occurs within the first six months of life and is a form of monogenic diabetes. 50% may have a lifelong form called permanent neonatal diabetes mellitus, while for the other 50%

the condition disappears after a few months' onset but can reoccur later in life and is called transient neonatal diabetes mellitus.

9. Brittle diabetes, a form of type I diabetes, causes frequent and severe blood sugar level fluctuations, often causing hospitalization. In rare cases, a pancreas transplant may be necessary.

How Common is Diabetes

Diabetes is widespread, with Type 2 diabetes accounting for 90% to 95% of cases globally. Approximately 537 million adults worldwide have diabetes, and projections estimate a rise to 643 million by 2030 and 783 million by 2045. Kenya, according to the International Diabetes Federation (IDF), ranks 31st among African countries

for diabetes prevalence, with around 460 cases per 10,000

Causes of Diabetes

people.

High blood glucose levels in the bloodstream causes

diabetes, regardless of the type. This stem from various causes specific to each type:

- a) Insulin resistance: Cells in muscles, fat, and the liver fail to respond effectively to insulin, possibly due to obesity, lack of exercise, hormonal imbalances, genetic factors, or certain medications.
- b) Autoimmune diseases: Type I diabetes and LADA occur when the immune system targets and destroys insulinproducing cells in the pancreas.
- c) Hormonal imbalances:
 Conditions like pregnancy,
 acromegaly, or Cushing
 syndrome can disrupt hormone
 levels, impacting blood sugar
 regulation.
- d) Pancreatic damage: Physical harm to the pancreas impairs its ability to produce insulin, leading to elevated glucose levels.
- e) Genetic mutations: Specific mutations can lead to MODY and neonatal diabetes, affecting how the body produces or processes insulin.

How is Diabetes Diagnosed

Healthcare providers diagnose diabetes through blood tests that measure glucose levels using three methods:

The diagnostic tests used to detect diabetes vary based on the type of diabetes.

Diabetes Mellitus

- Glycated haemoglobin (HbA1c) test
- Fasting plasma glucose (FPG)
- · Oral glucose tolerance test (OGTT)
- Random blood sugar test (RBS)
- Postprandial plasma glucose (PPG)

Management of Diabetes

Managing diabetes is complex and involves a range of strategies that work together with your healthcare provider.

Prognosis of Diabetes

Living healthily with diabetes is entirely possible by focusing on four key factors: making lifestyle changes, engaging in regular exercise, implementing dietary adjustments, and consistently monitoring blood sugar levels.















